AGREEMENT FOR CREDIT

1. The undersigned Applicant certifies that the information contained in this application is for the purpose of procuring and establishing credit with Camarillo Electric Supply, Inc.
2. Applicant agrees to make payment in full to Camarillo Electric Supply, Inc. for all purchases under the agreed **2/10 Net 30 terms**.
3. Applicant acknowledges and agrees that if the account balance exceeds the approved credit limit, no additional invoices or purchases may be charged to the account until the outstanding balance is paid down below the credit limit.
4. Applicant agrees to promptly notify Camarillo Electric Supply, Inc. of any changes to their customer profile and maintain current, accurate contact details, including physical address, phone number, and email addresses.
5. Invoices **paid within ten (10) days** of the original invoice date are eligible for a **2% early payment incentive**. The discount must be taken by the Applicant at the time of payment to be eligible. Discounts will not be applied after payment has been received. Payments must be made by ACH, CHECK or CASH. Credit card payments are not eligible for the discount.
6. The Applicant agrees to pay a **late fee of \$25.00 or 1.5%** on invoices that exceed 30 days from original invoice date, including every 30 days thereafter until payment is received in full.
7. **Payments not received within 90 days** of the invoice date shall be deemed severely past due. By executing the Agreement, Applicant authorizes Camarillo Electric Supply, Inc. to automatically withdraw funds from the bank account and/or credit card on file for the total outstanding balance, including any accrued late fees. In the event an attempted automatic charge fails or is declined, Applicant remains fully responsible for the outstanding balance and agrees to immediately provide an alternative payment method.
8. Camarillo Electric Supply, Inc. reserves the right to suspend services, withhold deliverables, or pursue further legal collection remedies until all overdue balances are paid in full.
9. Applicant further agrees to pay reasonable attorney fees and all other costs and expenses incurred in the collection of any obligation. Jurisdiction and venue for any legal action shall be in Ventura, California.
10. It is the responsibility of the **Applicant to ensure orders are correct** and meet job specifications or design criteria. The Applicant relieves Camarillo Electric Supply, Inc. of all liability resulting from material that fails to meet job specifications and design criteria.
11. The only warranties that apply to the materials sold are the manufacturer's warranties. **There are no implied warranties** covering the materials sold to Applicant.
12. Applicant acknowledges that a **25% restocking fee** will be applied for special order returns.
13. The Applicant must notify Camarillo Electric Supply, Inc. of any change in ownership, and shall not transfer or assign its rights or obligations without the prior written consent of Camarillo Electric Supply, Inc.
14. The Applicant accepts personal responsibility for all amounts owed to Camarillo Electric Supply, Inc.
